Course Overview

Who believes in angels, demons, and the spiritual world? Could it be that the answer to this question demarcates global, class, and ecclesial differences among Christians, especially in terms of appropriate forms of pastoral care? This course will explore the ways biblical and theological visions of the spiritual world have been (a) critiqued within modernity (b) reflected on by liberation and third world theologians, and (c) discovered and appropriated by post-colonial theologians. It will move from an examination of the treatment of the spiritual world in modern and post-modern thought to a psychotheological paradigm for pastoral care that takes seriously cultural and theological contexts where the spiritual world characterizes common life. Ultimately, the course hopes to pose the fundamental question of whether belief in the spiritual world is primarily a cultural specific vision (and thusly to be localized) or primarily a Christian specific vision (and thusly to be universalized) or both, and explores the implications of answers for pastoral care and counseling using case studies.

Objectives of the Course

- (1) To reflect biblically, theologically, and psychologically on the portrayal of the spiritual world in the various readings
- (2) To be able to formulate and articulate one's own theology of the spiritual world and its effects on human life
- (3) To apply such acquired knowledge in pastoral intervention especially in cases where the spiritual world characterizes common life.

Course Requirements

- (1) <u>Assigned Readings</u>. All students are **required** to do the weekly readings and come prepared to discuss them in class.
- (2) Four Short Papers.

- A 1-page **Reflection** on First Two Chapters of Allison, *Encountering Mystery* Due February
- Critique of Bultmann (5 pages): <u>Due March</u>
- Theology of the Spiritual World (7 pages): <u>Due April</u>
- Significant Learning (10 pages): <u>Due May.</u>

(3) Group Discussion

Each student is required to lead the class in discussions on an assigned day. Leading requires that you come to class with a set of questions and issues based on the readings, for discussion that day. You will also be expected to facilitate part of the discussion for that class

(4) Significant Learning:

A thoughtful and focused summary of the core issues that you have identified relative to your growth and development as a pastoral caregiver with regard to spiritual dimensions of pastoral care. This is an integrative paper in which you make **connections** among the **theoretical**, **practical** and **personal components** of the course. **Due May**

(5) Grading

Your final grade will be based on the quality of your class participation and your four papers. Your papers will be graded on the basis of

- (a) accurate use of course readings, lectures and discussion,
- (b) thoroughness and clarity of thought
- (c) creativity and depth of insight.
