Course Description

This course explores intersectional approaches to how knowledge (variously construed) is constructed and norms are established related to heteronormativity and people who identify as lesbian, gay, bisexual, transgender, and otherwise under the queer umbrella. A background knowledge of queer theory is presumed as the course focuses on the current development of queer theoethics scholarship, with preference given to authors writing out of a Christian social ethics approach.

Learning Objectives

During the course, students will:

- Examine the traditions of queer theory that have influenced Christian theoethical scholarship.
- Study a range of Christian social ethics approaches to queerness.
- Explore queer ethical responses to socio-political concerns including gender and sexual oppression, disability discrimination, racism, sexual violence, and ecological degradation.

Targeted Learning Outcomes:

By the end of the semester, students should be able to:

- Lead and contribute to informed discussions on how theoethical scholarship is transformed by queer studies.
- Critically analyze queer and quare Christian social ethics resources and their contribution to religious studies as well as Christian communities.
- Demonstrate, through class leadership and written work, the ability to translate normative insights related to queer theory and queer theoethics for more just political, cultural, planetary and religious futures.

Critical Academic Book review

Style: 12 pt font, double spaced, 2000 words

How to: Consider the following as a helpful guide to get you started on your critical book review.

- bibliographical info (to be inserted at the beginning of the review): author, title, publisher, date, ISBN number, # of pages (Look up some reviews on ATLA to see the typical formatting)
- the identity of the author,
- the genre, intended audience, and purpose of the work
- the appropriateness of the title -- how well does it communicate the book's contents?
- the Preface/Introduction/Table of Contents: What do you learn about the book from the Preface and Introduction? How is the book arranged: sections, chapters?

- the main argument of the book: How does it progress? What support does the author summon? Does the book fulfill its stated purpose?
- Key Ideas: What are the main ideas presented in the work? What makes the book worth reading?
- Who is your own targeted audience who will not have read the book? Summarize in a way that will help your readers gauge their interest.
- An assessment of the work: What were the book's strengths and weaknesses? Did the book appeal to you (intellectually? theologically? ethically? emotionally?)?
